## NTA Update

30 September 2005

The unaudited NTA as at 30 September 2005 is **111.2 cents per share** after tax and after paying the final dividend relating to the financial year ended 30 June 2005 of 4.0 cents per share which was paid to shareholders on 30 September 2005. The performance of the NTA after tax for the month is 2.2% (year to date performance excluding the 2005 final dividend: 4.3%).

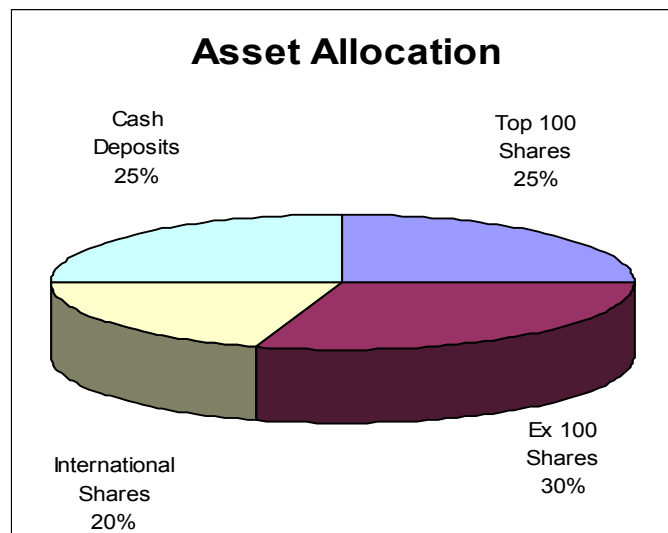

The Company has a predominantly long term investment strategy and does not intend disposing of its long-term investment portfolio.
