

Annexure “A”

Disclosure under section 672B of the *Corporations Act 2001*

Questor Financial Services Limited (“*Questor*”) under direction of subsection 672A(1) of the *Corporations Act 2001* (Cth) states the following:

Questor is an Approved Trustee and Responsible Entity of The Portfolio Service Retirement Fund (“*TPSRF*”) and The Portfolio Service - Personnel Investment Plan (“*TPSPIP*”).

TPSRF is a complying superannuation fund under the provisions of the *Superannuation Industry (Supervision) Act 1993* (Cth). TPSPIP is an unlisted managed investment scheme registered under the *Corporations Act 2001*. All such holdings purchased for cash are set out below:
